### Examination of the South Oxfordshire and Vale of White Horse Joint Local Plan 2041 – Procedural Meeting – 12 February 2026

1. In our letter of 6 January 2026, we informed the Councils of our intention to hold a Procedural Meeting (PM) to discuss the best way forward for the examination process in light of recent announcements regarding the Duty to Cooperate. The Councils have since liaised with us via the Programme Officer (PO) to agree a date and venue for the PM.

4. The PM will focus on the practical arrangements of resuming the examination in light of the anticipated change to legislative arrangements. **Importantly, there will be no discussion of evidence or soundness matters at the PM.**

There will be an opportunity for questions to be put to the Inspectors and for the Inspectors to put questions to the Councils. The PO will publish the note of the PM as soon as practicable afterwards.
