

## Chalgrove Neigbourhood Development Plan Review Modification Statement

12<sup>th</sup> December 2023

Under Regulation 17(e)(ii) of the Neighbourhood Planning (General) Regulations 2012 (as amended), the local authority must submit to the examiner a statement setting out whether or not the authority consider that the modifications contained in the modification proposal are so significant or substantial as to change the nature of the neighbourhood development plan which the modification proposal would modify, giving reasons why the authority is of this opinion.

The Chalgrove Neighbourhood Development Plan (CNDP) was made as part of the district council's development plan on 20 December 2018. Since the adoption of the CNDP, the South Oxfordshire Local Plan 2035 was adopted in December 2020. Since the CNDP was made the National Planning Policy Framework (NPPF) has also been updated, with the latest revision dated 5 September 2023.

The CNDP Review is seeking to respond to these local and national planning policy changes. The changes are as follows:

Document "01.-Chalgrove-Neighbourhood-Development-Plan" has been updated to include a revision level and date in the footer to enable more robust revision level control.

The final paragraph of the Introduction has been changed to reflect that the CNDP is now made.

Section 2.2 has been updated to show that the current Local Plan is the Adopted Local Plan 2035

Section 2.7 has been updated to show that the CNDP is now made.

The Basic Conditions Statement has been updated to reflect the policies within the CNDP that meet the current Adopted Local Plan 2035

The following Policy section changes have been made:

Policy C1 – no change

Policy C2 – Updated to add a reference to the new Design Guidance and Codes document which now forms part of the CNDP. The specific update is the addition of item j) - All planning proposals should adhere to the Chalgrove Design Guidance and Codes document to ensure coherence with, and enhancement of, the character of the area Policy H1 – no change

Policy H2 – no change Policy H3 – no change Policy H4 – no change Policy H5 – no change Policy CF1 – no change Policy CF2 – no change Policy CF3 – no change

A new Core Document has been produced – the Design Guidance and Codes document. This document sets out design guidance and codes based on the existing features of Chalgrove. The Design Guidance and Codes are intended to sit alongside the CNDP to provide guidance for applicants preparing proposals in the area and as a guide for the Neighbourhood Development Plan Steering Group and South Oxfordshire District Council when considering planning applications. It sets out the expectations for proposals and ensures that they will reflect on Chalgrove's key defining features.

There are no other changes to the CNDP core documents, supporting documents or appendices.

The Planning Practice Guidance sets out the types of modifications which can be made to the neighbourhood plan. These are:

- Minor (non-material) modifications to a neighbourhood plan or order are those which would not materially affect the policies in the plan or permission granted by the order. These may include correcting errors, such as a reference to a supporting document, and would not require examination or a referendum.
- Material modifications which do not change the nature of the plan or order would require examination but not a referendum. This might, for example, entail the addition of a design code that builds on a pre-existing design policy, or the addition of a site or sites which, subject to the decision of the independent examiner, are not so significant or substantial as to change the nature of the plan
- Material modifications which do change the nature of the plan or order would require examination and a referendum. This might, for example, involve allocating significant new sites for development.

In the opinion of Chalgrove Parish Council, the proposed modifications are not considered to be so significant or so substantial as to change the nature of the plan. The goals and objectives of the plan have been updated, but they remain largely unchanged in their nature. Therefore, in the Council's opinion, the plan should undergo an independent examination, but it should not require a new referendum.
