Visited the Towersey site with my colleague Dani Rogers commencing 10:30am on 2 November 223 for the purpose of serving copies of interim injunction. No one was present on the site at the time of our visit. We served three copies of the interim injunction and related bundles sealed inside a clear weather proof sleeve fastened to a post, the barn and a fence respectively. Photographs of our site visit are on file. The whole of the site has now been disturbed by clearance and releveling works, without planning permission and with little, if any, vegetation now remaining on the site. Close boarded fencing to the northern side boundary ranged in height from 2.0 - 2.35m, exceeding permitted development rights. Close boarded fencing to the southern Side boundary ranged in height from 2.0 - 2.5m, again exceeding permitted development rights. Water supply pipes have been laid with a total of 5 taps attached to close boarded fences in various locations around the site. The two of the paddocks to the front of the site on either side to the central track each contain two taps. These paddocks fall outside of the area approved for the barn conversion. Only one tap appears to be within the red edged area of the above permission. No work has been done to the barn and stable buildings to implement the extant permission

We left the Towersey site at 11:00am.

We then drove a short distance to the Moreton Site for the purpose of serving copies of the interim injunction arriving at approximately 11:15am.

We approached the first of four caravans present on the site where we initially met a young man who asked if he could help us. I explained that we were looking for individuals answering to the names Darren Smith, Milo Lee and Darren Lee. A young woman then came out and explained that none of them were around and that she and the two young men inside the caravan were the only people present on site. I then explained the purpose of our visit and that I intended to hammer a wooden post into the ground and attached a copies of the bundle of documents containing the interim injunction ('the Bundle'). The young woman then informed us that Darren Smith was her father and that she was happy to pass on a copy of the Bundle to him. I asked her for her name, to which she replied Megan. I then handed her a copy of the Bundle. I then asked if she could tell me which of the caravans were occupied by Milo Lee and Darren Lee. She then informed me that they were her brothers and that she would be happy to pass on copies of the Bundle to them too.]

The young woman identified herself as Megan. Rob and I left the Moreton site at 11.30am. Photographs of this site visit can be found at exhibit DLR3.

We approached the first caravan and met a young teenage girl and two teenaged boys. I ask if Darren Smith, Darren Lee or Milo Lee were present to which she replied "No, they are all away". I explained the purpose of our visit and explained that we would hammer a stake in the ground and attach a copy of the injunction to it. She then identified herself as being Darren Smith's daughter and offered to take a copy of the injunction bundle to give to him. I asked her for her name to which she replied "Mehgan". I then thanked her for her time and we left the Moreton site at approximately 11:30am.
