COMMUNITY GOVERNANCE REVIEW

TERMS OF REFERENCE

Introduction

The council's Community Governance and Electoral Issues Committee ("the committee") has agreed to undertake a community governance review (CGR) pursuant to Part 4, Chapter 3 of the Local Government and Public Involvement in Health Act 2007 of part of the district of South Oxfordshire. The 2007 Act vested powers in the council to undertake such a review and the council has delegated those powers to the committee.

The committee will undertake the review in accordance with the guidance on community governance reviews issued by the Department of Communities and Local Government and the Local Government Boundary Commission for England (LGBCE) in March 2010 ("the guidance").

What is a Community Governance Review?

Community Governance Reviews provide the opportunity for South Oxfordshire District Council to review and make changes to community governance within the area. The recommendations made in such a review have two main objectives:

- To improve community engagement and better local democracy.
- To enable more effective and convenient delivery of local services.

A Community Governance Review considers one or more of the following:

- Altering the existing boundary of a parish.
- Creating, merging or abolishing parishes.
- Changing the name of existing parishes.
- The electoral arrangements for parishes (e.g. how many parish councillors are required and parish warding).
- Grouping parishes under a common parish council, or de-grouping parishes.
- The "style" of a new parish (enabling an area to be known as a town, community, neighbourhood or village rather than a parish).

Proposals for consideration

The committee proposes to consider the following parish matters:

Assessment criteria

The factors that the council will take into account in making decisions are as follows:

- natural or man-made boundaries that help to define clearly one community from another
- housing developments that straddle parish boundaries, thereby resulting in people being in different parishes from their neighbours
- effective and convenient representation of local residents at parish level
- views expressed in relation to any changes, particularly from those people directly affected
- the extent to which proposals reflect the identities and interests of the affected community
- the size and population of the local community

Why is the Council undertaking the review?

The guidance states that it is good practice for principal councils (in this context that means this council) to undertake CGRs every 10-15 years. The council completed a review of the whole district in 2014 and agreed to undertake a further review every four years with any changes to be implemented for the next scheduled elections. Reviews were subsequently undertaken and changes were implemented at the scheduled elections in May 2015, May 2019 and May 2023. Any changes agreed as part of this review will be implemented for the elections in May 2027.

In late 2025 the council invited parish councils to submit matters for review. The council's Community Governance and Electoral Issues Committee considered all the formal requests at its meeting on 13 January 2026 and agreed to review those matters set out under proposals for consideration.

Consultation

The committee will consult formally on the review and will take full account of the views made by, and suggestions of local people and organisations. In particular, the council will consult local government electors/residents in the relevant parishes, town and parish councils, district councillors and the Oxfordshire Association of Local Councils.

Timetable

The 2007 Act requires the council to complete a CGR within 12 months of the date of publication of terms of reference. The proposed timetable complies with the legal requirement.
